Notice of Race

1. **RULES:** The series will be governed by the rules as defined in *The Racing Rules of Sailing*.
2. **ENTRY:** All entrants must be PHRF ratable yachts of conventional hull design with bunks and head, auxiliary power, self-righting, self-bailing cockpits and fulfill U.S. Coast Guard regulations. The LSSC Race Committee will assign a rating to any yacht without a valid rating certificate. Eligible boats may enter by completing the Application, found at <http://www.lakeshoresailclub.org> and sending it with the required fee before the first race of the series.
3. **FEES:**

Spring Series:	\$70 (add late fee after May 14)
Summer Series:	\$70 (add late fee after July 30)
Both Series:	\$130 (add late fee after May 14)
Late Fee:	\$25
4. **SCHEDULE:** Two series run on six consecutive Wednesday evenings. The First start is at 1900 hours.

Spring Series:	May 19, 26, June 2, 9, 16, 23
Summer Series:	Aug 4, 11, 18, 25, September 1, 8
5. **SAILING INSTRUCTIONS:** The sailing instructions are posted on <http://www.lakeshoresailclub.org>.
6. **RESULTS:** Individual Race results will be announced after each race at **Dragon's Landing**, 24409 Jefferson Ave., St Clair Shores. Any change in post-race meeting location will be announced prior to the race. All race results will be posted on: <http://www.lakeshoresailclub.org> within 24 hours after the race.
7. **AWARDS:** First, Second, and Third place Series awards shall be given for each class. Overall awards shall be presented for each series as well as the combined series for the top three positions. These flags will be presented at the LSSC Sunset Series Awards Party.
